Additionally, financial damages are evaluated in cases involving an insurer, including business interruption claims and loss of profits.

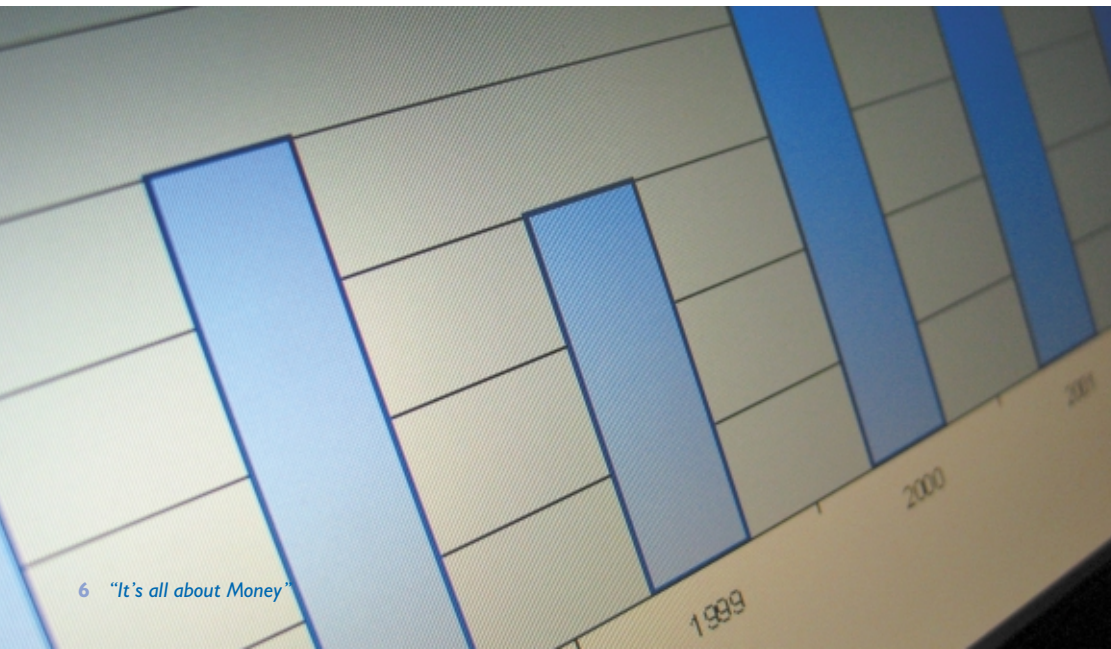
